- Carry out business activities in a sustainable manner which consistently provides services that conform to contractual arrangements, promotes customer satisfaction and achieves continual improvement in Health and Safety performance of Brown and Mason.
- Comply, so far as is reasonably practicable, with all relevant legislation and other applicable requirements to which Brown and Mason has subscribed.
- Ensure, so far as is reasonably practicable, that Health and Safety aspects are taken into account when planning and implementing new work projects and managing change.
- Develop communication channels to ensure, so far as is reasonably practicable, this policy, our objectives and requirements are understood and complied with by personnel and contractors working on behalf of Brown and Mason.
